Meeting minutes SEB-ESA Executive Committee

Date: 4 November 2016 (via Zoom)

1. In Attendance

David Riley, JC Chong, David Jenkins, Nancy Hinkle, Steve Lapointe, Stormy Sparks, and Tim Schowalter Quorum (4) was met.

2. Call to Order

SEB President David Riley called the meeting to order at 10:00 am.

3. Constitutional and By-Law Amendments Riley suggested that the attending Executive Committee (EC) members consider the editorial changes first.

Chong suggested that some of the proposed editorial changes involved the format of ballots (i.e. written and electronic), they should be considered more substantial changes, and should be considered separately. Riley agreed to adopt the suggestion.

Riley moved that the three editorial changes (Constitution, Article VIII, Section 2; By-Laws, Article III, Section 1 and 5) be approved for amendment. Motion seconded by Sparks. Motion approved unanimously by voice vote.

Riley motioned that amendments correcting "written or electronic ballot" (By-Laws Article II, Section 7) and "electronic or printed ballot/form" (By-Laws, Article III, Section 13; Article IV, Section 2) to simply "ballot" be recommended for approval. Seconded by Jenkins and Lapointe.

Discussion: Sparks questioned if such amendment will open the balloting system to any ballot format? Chong answered yes. Lapointe suggested that the EC leaves the ballot format open so that other format could be used in the future. Riley reported that the By-Law Committee wanted to leave it alone under the principle of "don't fix it if it is not broken". Sparks suggested that the current wordings are not necessary. If voting technology changes, SEB will be able to adopt any format if the wording is just "ballot". Lapointe questioned if the ballots are recorded. Chong answered yes. Lapointe cautioned that any ballot format we use, it should be able to be recorded.

Riley called for each member to vote. The motion was approved unanimously.

Riley motioned to accept the date changes at the top of the document. Seconded by Schowalter. No discussion followed. Motion accepted unanimously.

Lapointe motioned to recommend approval of the proposed amendment to Constitution Article I, Section 2. Seconded by Schowalter. No discussion followed. Motion approved unanimously.

Schowalter motioned to recommend approval of proposed amendment to Constitution Article II, Section 2. Motion seconded by Chong.

Discussion: Lapointe questioned if he does not live within SEB area, can he still be a member. Most answered yes, the amendment will allow that. Sparks suggested that the current language is too wordy anyway. Sparked also questioned if a person lives in the SEB area, can the person choose not to be a SEB member? Chong answered that, based on SEB membership guidelines, primary branch membership is based on a member's physical/mailing address, but the member can join additional branch with a fee to ESA.

Hinkle questioned if SEB does not change the constitution, would be in conflict with the parent organization. Riley answered that ESA would like the constitution to be uniform across branches and ESA. But the branch does have autonomy to the manner in which the branch is run.

Motion was approved unanimously by voice vote.

Sparks motioned to recommend approval of proposed amendment to Constitution Article III, Section 1. Motion seconded by Hinkle. No discussion followed. Motion approved unanimously.

Chong motioned to recommend approval of proposed amendment to Constitution Article X, Section 3. Motioned seconded by Schowalter. No discussion followed. Motion approved unanimously.

Schowalter motioned to recommend approval of proposed amendment to Constitution Article X, Section 4. Motion seconded by Lapointe. No discussion followed. Motion approved ananimously.

Schowalter motioned to recommend approval of proposed amendment to By-Laws Article I, Section 2. Motion seconded by Lapointe. No discussion followed. Motion approved unanimously.

Hinkle motioned to recommend approval of proposed amendment to By-Laws Article II, Section 5. Motion seconded by Chong.

Discussion: Lapoint asked if a person can fill the vacancy of the Representative to the Governing Board, serve out the remaining term, then run for two more consecutive 3-year terms? Based on the proposed amendment, yes. Riley suggested that to leave it open-ended it would allow some flexibility in interpretation.

6 attending members approved the motion; 1 opposed. Motion carried.

Hinkle motioned to recommend approval of the proposed amendment to By-Laws Article II, Section 7. Motioned seconded by Sparks and Schowalter.

Discussion: Chong stated that the result of the officer election is typically announced at the opening business meeting. Would the existing language of announcing the results at the final business meeting (both in the current and proposed amended versions) conflicts with our actual practice? Sparks suggested that the current language does not prevent announcing the results during the opening session. Schowalter suggested that the final business meeting can be interpreted as the official time for announcement.

Motion was approved unanimously.

Schowalter motioned to recommend approval of the proposed amendment to By-Laws Article III, Section 2. Hinkle seconded the motion. Riley explained that the rationale for this amendment is the fact that electronic ballots are counted by ESA staff, so the Nominating Committee is only verifying the ballots. Chong cautioned that the entire procedure for proposing and approving by-law and constitutional amendments are not in keeping with our actual practices. The procedure for the approval constitutional and by-law amendment by the membership should be revamped. Chong will work with ESA staff to make sure the procedures outlined in the constitution and by-laws are followed. Riley suggested that Lapointe forms a committee to consider amending the procedure after taking office in 2017.

Motion was disapproved unanimously.

Sparks motioned to recommend approval of the proposed amendment to By-Laws Article III, Section 15. Motion seconded by Schowalter.

Chong questioned who will appoint the committee members? Answered, the President, as would be other standing committees.

Motion approved unanimously.

Subject: One additional amendment to SEB Constitution for consideration

Hello, everybody.

I would like to propose one additional amendment to the SEB Constitution -

Article X now reads:

"Section 5. Ballots shall be delivered to the Secretary-Treasurer not later than seven days prior to the date of the next annual Preliminary Business Meeting during the annual meeting.

Section 6. Ballots received by the Secretary-Treasurer shall be tabulated at the annual meeting by the Nominating Committee, and the results shall be announced at the Final Business Meeting. If two thirds or more of the ballots written cast favor the proposed amendment(s), it/they shall be adopted; otherwise it/they not be adopted."

With ESA now tabulating the ballots for SEB, the Secretary-Treasurer and the Nominating Committee are now taken out of the picture. I propose that the two section above me amended as

"Section 5. Results of the ballots shall be delivered to the Secretary-Treasurer no later than seven days prior to the date of the next annual Preliminary Business Meeting, and shall be announced at the Final Business Meeting. If two-thirds or more of the ballots favor the proposed amendment(s), it/they shall be adopted; otherwise it/they shall not be adopted."

This proposal will need to be seconded.
