The i-B Awards were launched on April 1st 2017. The branch has four awards this year – Distinguished Scientist Award, Early Career Research and Leadership Award, J.H. Comstock Award, and Graduate Student Award. The closing date for applications is July 1st except for J. H. Comstock (July 10th).

- c. The i-B has sent quarterly newsletters to our membership to keep members informed on branch news.

Branch Meeting News

1. 2016 International Branch Annual Business Meeting

The 2016 International Branch Annual Business Meeting took place during the 2016 International Congress of Entomology in Orlando, Florida on September 29, 2016 from 11:30AM-1:00PM. The meeting was attended by 42 members and guests. President Hardy gave the status of the Branch and the award program followed. Dr Charles Vincent, Dr Rajeswaran Jagadeesan, and Isobel Ronai were awarded Distinguished Scientist Award, Early Career Researcher Award, and Graduate Student Award, respectively, onsite. Dr Kiran Gadhave was recognized with J.H. Comstock Award, but he was not in attendance to receive the award. A luncheon discussion was held amongst members and guests on ways to initiate the web-based meeting for the Branch. Branch leadership began exploring options to do 2017 annual meeting through the web, with the aim of increasing attendance as well as to generate funds. The 2016 annual Business Meeting noted the value of physical meetings, but the distance, cost, and logistics associated with travel for International Branch members has necessitated a more creative way of conducting such meetings. The IB Governing Board agreed to explore mechanisms of such web-based conferences.

2. 2017 International Branch Annual Business Meeting

The 2017 International Branch Annual Business Meeting will take place at the Annual ESA Meeting in Denver, Colorado from November 5 to 8. A specific date and time has not yet been set. However, the format for this meeting will differ from previous years, especially that we plan to combine annual Business Meeting with a short scientific symposium. The first part of the meeting will be the International Branch Business while the second part will be used for our 2017 i-B Award winners and invited speakers to provide presentations on their research. Branch award winners will be presented with a plaque by President Megha Parajulee.

Current Membership and Financial Status

The International Branch currently has 583 members (as of March 2017). Membership has risen consistently each month since January 2016 (January: 516 members; February: 563; March: 583). International Branch membership currently accounts for 10.7% of ESA membership.
