Reviewing our WIGs

This is the second part of our continued discussion about WIGs. The P-IE GC is considering that we conclude WIG #1 and rephrase WIG #2 and elevate it to WIG #1 -- perhaps as, "By 2030, P-IE will be recognized as the lead national expert on pollinators; invasive, plantinsect interactions; and agroecosystem insect management." This goal would then be supported through the P-IE Science Policy Activities. The P-IE Science Policy Activity would then serve as a key objective for our membership to meet this goal and would be supported through online tools and with support through the P-IE Tour Oversight Committee. Additionally, with the conclusion of our exclusively, pollinator-focused goals, we would be ending the "P-IE Pollinator Committee" to be reformed into a new committee which will be charged with outlining integrative tools and communications strategies that aid in meeting our new Wildly Important Goal. Update from the ESA Governing Board

I have officially served my first year as our Section's representative to the ESA Governing Board and wanted to take the opportunity to provide you an update on my experiences and optimism about our Society. What is the Governing Board? The Board discusses ESA strategic initiatives, oversees the work of the ESA staff and volunteers, and advances new ideas to benefit the Society, meeting four times per year. The work of the Governing Board is transparent to all membership, with summaries published after each meeting to inform members of activities and decisions. One of the most significant **discussions continues to be related to how ESA prepares** for the potential of a significant revenue shortfall when the contract with Oxford ends in December 2024. Partly in response to these changes in journal revenue predictions, the Governing Board appointed a Publications Task Force in late 2017 and charged them with developing a set of recommendations to address these expected losses. *[continued on page 2]*

Update from the ESA Governing Board (continued)

In June 2018, one of the final recommendations of the task force was to encourage the board to consider reinstating page charges within the next 1-2 years. Given the reductions in our projected revenue with Oxford and the shortfall this could create beginning in 2025, and the increasing importance of transformative agreements, the Governing Board has voted to reinstate page charges for ESA members publishing in ESA's subscription journals. ESA staff and the Governing Board are also considering other mechanisms for generating revenue for the Society. *This circumstance that ESA is challenged with serves as an excellent example for how our Society addresses a problem – proactively, developing solutions through engagement with a focused group of members to provide recommendations, oversight and approval by the Governing Board, and execution by ESA staff.*

The Governing Board is also focused on members and meeting their current and future needs. Discussions include ESA's meeting strategy, efforts to support entomologists with nonacademic career tracks, and continued role in Science Policy. Actions taken by the Governing Board and with members in mind include, extension of the Diversity & Inclusion Committee and approving a new Committee on Leadership and Development and Canvassing for Awards and Honors, charged with ensuring diversity in the pool of individuals pursuing leadership roles in the Society and Society awards. I am proud to serve as Chair of this committee and developing future programming recommendations.

As your Section voice to the Governing Board, I would appreciate feedback from you on any topics currently being discussed or new topics that should be discussed. Is the Society meeting professional and scientific needs of members? What ideas do you have for improving the member experiences and growing the Society? Thank you for the opportunity to serve you!
